- ❖ The Bremer County Community Foundation funded 23 projects through the 2008 Discretionary grantmaking process.

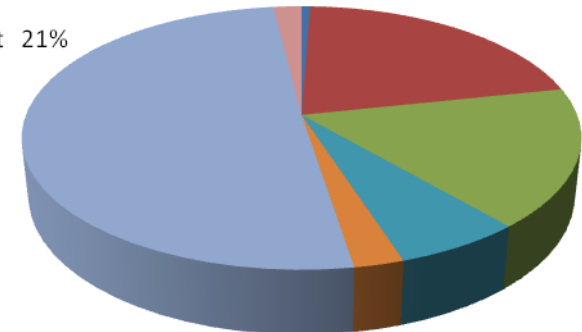
