- ❖ The Floyd County Community Foundation funded 17 projects through the 2008 Discretionary grantmaking process.

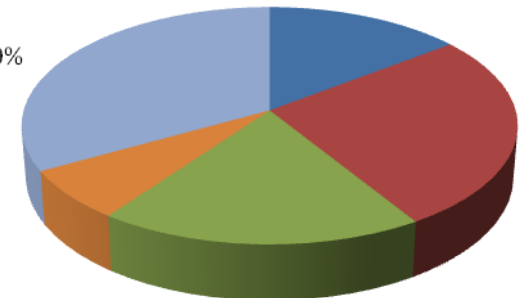

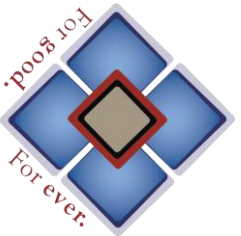
