- ❖ The Community Foundation of Franklin County funded 21 projects through the 2008 Discretionary grantmaking process.

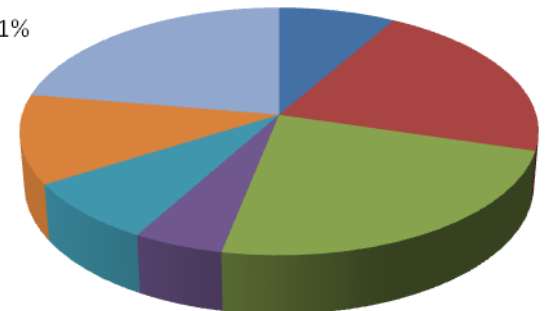
