

Our Funds

There are many types of funds within the foundation. A donor may give to an existing fund or choose what type of fund they wish to establish at the time of their contribution.

Unrestricted Charitable Fund

Offers the broadest giving option, allowing grants to be made wherever the community's needs are the greatest.

Donor Advised Fund

Enables the donor to recommend specific organizations to receive grants.

Designated Fund

Enables donors, at the time of their gift, to name an organization that will benefit from the fund each year.

Scholarship Fund

Helps students pursue academic goals. Donors may define guidelines for candidacy, the advisory committee, the school and the award itself.

Field of Interest Fund

Supports grants to meet a particular need or geographic area of interest to the donor.

Non-Profit Agency Endowment Fund

Established by non-profit organizations to provide income. The Kossuth County Community Foundation handles all administrative and investment responsibilities, freeing the organization to pursue its charitable mission.

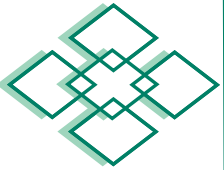
