- With some exceptions, organizations are limited to one application per calendar year\*.  
*\*Organizations that are exempt from this restriction include the Cedar Falls School District, the City of Cedar Falls, the City of Waterloo, Hawkeye Community College, University of Northern Iowa, and the Waterloo Community School District.*
- Fiscal sponsors may also submit up to one additional proposal within the same calendar year.

## Grant Amounts

The majority of our competitive grants range from \$5,000 to \$25,000, with some grants exceeding that range. ## Eligibility Details

Organizations must provide benefits to the people of Black Hawk County **and** meet the following criteria:

- Be classified as a 501(c)(3) nonprofit organization or be a government entity. Tax-exempt organizations classified as *other than* 501(c)(3) are also eligible *if and only if* the project is deemed charitable; please contact our office to discuss the project's eligibility prior to submitting a proposal.
- For groups, projects, or initiatives that do not meet the above eligibility requirement, we will consider projects submitted through a fiscal sponsor. Fiscal sponsors must be classified as a 501(c)(3) or a government entity. CFNEIA prefers the fiscal sponsor's mission closely align with the sponsored project.
- Applicants must be current with all state and federal reporting requirements.

In addition, the following conditions must be met:

- Applicants must not have any past due grant reports for previous CFNEIA grants.
- Applicants with a separate supporting, eligible organization (like a "friends of" or a foundation) can apply through either the organization or through its supporting organization, but not both. The Foundation encourages applications to be submitted through the supporting organization.
- The Foundation will consider requests for capital campaigns but will not provide multiple grants (in subsequent years) for the same campaign.

## Eligibility Based on Funding Type

We believe you know how to best utilize the resources you have to provide service to our community and as such, we **STRONGLY ENCOURAGE** 501(c)3s to apply for general operating support. The following is an outline of what funding types are eligible based on the organization applying:

## Ineligible Requests

- Requests for retroactive funding (projects/programs that have already occurred prior to funding).
- Requests for regranting purposes.
- Requests for debt reduction.
- Requests for individuals.
- Requests for for-profit entities.
- Requests for associations that only benefit its members and not the community at-large.
- Requests for political doctrine and lobbying or religious activities and proselytization.
- Requests that violate our Nondiscrimination Policy.

## What We Fund

## The Grant Selection Committee

Our [Black Hawk County Grants Distribution Committee](#), composed of Community Foundation board members and community volunteers from throughout Black Hawk County, is charged with making funding recommendations to the CFNEIA Board of Directors after reviewing and evaluating all eligible applications.

## How We Evaluate Your Application

The first step of evaluating applications includes a review by our staff to confirm eligibility. All eligible applications are then shared with our Distribution Committee who evaluates them based on the following:

- Organization Capability – *Is the organization the right agency for this project? Are they capable of doing the work?*
- Community Need – *What level of community need does this request address?*
- Collaboration – *Is the organization collaborating with the appropriate agencies on this project?*
- Budget – *Does the organization have a clear and well-prepared budget?*
- Alignment with CFNEIA's Strategic Initiatives – *Does this request align with CFNEIA's strategic initiatives in the areas of child care, the arts, workforce development, racial equity, and/or nonprofit capacity building?*
- BIPOC Led Nonprofit – *Is this organization listed in the Community Foundation's BIPOC Led Directory?*
- Transformational – *Does this request address change at the systems level? Is it a 'game changer'?*

Once all evaluations are complete, the Distribution Committee meets to discuss and deliberate, using the evaluations as a guide to make determinations for funding.
