Fee Definitions

Audit Fees support the Foundation's cost for the yearly audit of our overall finances.

Investment Fees are the Foundation's cost to manage its investments and are prorated quarterly based on the current market value.

Supportive Contribution Fees are deducted from funds quarterly to help support the cost to operate the Foundation, a nonprofit organization. See the chart below.

Credit Card Gift Fee: Gifts made to funds via credit card will be charged a 3.5% fee. This does not affect the taxable donation amount of the gift, but will add an additional fee per credit card transaction to the fund.
