## Added Tax Benefits of Giving

The Impact Fund is eligible for the Endow Iowa 25% state tax credit. Gifts to permanent endowment funds of the Community Foundation that benefit Iowa charitable causes are eligible to receive a 25% state tax credit through the Endow Iowa program.
