How Our Impact Priorities Guide Us

Our impact priorities guide where and how we invest in our communities. They help focus our grantmaking on projects that build opportunity, strengthen community connections, and create long-term impact. We encourage applicants to consider how their work aligns with these priorities.

Opportunity & Access

Everyone deserves the chance to reach their potential. We partner with organizations and actively work to remove barriers and expand pathways to opportunity so all people, especially those in underserved and rural areas, have equitable access to the resources and support needed for economic prosperity.

We welcome proposals that demonstrate a critical need and provide a solution that creates opportunity & access for residents in our county.

Health & Safety

Every person has the right to live in a safe, stable, and healthy environment. We work with organizations providing essential health and human services.

We welcome proposals that promote health and safety in our county and have an interest in funding organizations and local government entities that ensure the general safety of all residents and those who demonstrate meaningful outcomes related to critical health issues facing individuals in our county.

Vibrant Communities

Vibrant Communities are places where people want to live, work, and play. We connect and collaborate with organizations bringing neighborhoods to life through arts, culture, recreation, and economic development.

We welcome proposals that contribute to building Vibrant Communities in our county. We have an interest in funding organizations and local government entities that demonstrate their contributions to long-term vitality by enhancing quality of life for a broad segment of our population through amenities and places people love to be. We also have an interest in funding organizations and entities that are strengthening the ability of our county to attract and retain residents, businesses, and visitors.

Youth Empowerment

Young people are the future leader and changemakers of our region. We support programs that provide educational opportunities, leadership development, and mentorship.

We welcome proposals that meet the unique needs of young people in our county by empowering them through meaningful development opportunities. We have an interest in funding organizations that ensure children are cared for and families are supported.

Eligibility to Apply

Organizations must provide benefits to the people of the Grundy County *and* must meet the following criteria to apply for a grant:

- Classified as a 501(c)(3) nonprofit organization or be a government entity.
- Tax-exempt organizations classified as *other* than 501(c)(3) are also eligible *if* the project is deemed charitable; please contact our office to discuss the project's eligibility prior to submitting a proposal.
- Current with all state and federal reporting requirements, such as filing of 990 forms.
- No past due grant reports for previous Grundy County Community Foundation grants.
- Requests that include or require participation in inherently religious activities such as religious worship, instruction, or proselytization or activities that promote specific religious doctrine are not eligible.
- Application must be completed by the due date using the online application and CFNEIA grant site.

Groups, projects, or initiatives that do not meet the above eligibility requirements may submit a request through a fiscal sponsor. Fiscal sponsors must be classified as a 501(c)(3) or a government entity. The Foundation prefers that the fiscal sponsor's mission closely aligns with the sponsored project. **Fiscal Sponsors will be legally and financially responsible for any grant funds that are awarded.**

Eligibility Based on Funding Type

We believe you know how to best utilize the resources you have to provide service to our community, and as such, we *encourage* 501(c)3s to apply for general operating support. The following is an outline of what funding types are eligible based on the organization applying:

**Request must be charitable and benefit community as a whole (i.e. community programming, space, etc).

***For Fiscally Sponsored entities, please contact our office to confirm eligibility for operations funding.

Restrictions

- One application per organization with the exemption of Government Entities and Fiscal Sponsors.
- Fiscal sponsors may submit only one application per sponsored organization.
- Government entities may submit only one application per department. Schools are considered government entities for grant purposes.
- Grant request minimum is \$1,000.
- **Applicants must use the Budget Template that is linked in the application** to provide a detailed **Request Budget** listing all expenses and income sources **specific to the request**. *See budget template on page 4 for sample.*
- Applicants are strongly encouraged to include bids and/or estimates for equipment and materials being requested.
- Requests for debt repayment and/or pass through funds (funds to be paid to another entity) are not eligible.

Review Criteria

Applications will be reviewed and scored on the following elements:

Impact Criteria — Reviewers will assess how well the proposed project addresses a clear Community Need & Impact potential in Grundy County, and how strongly it aligns with one of the county's four Impact Priorities (Opportunity & Access, Health & Safety, Vibrant Communities, and Youth). Impact is the most important factor in scoring.

Core Criteria — Reviewers will also evaluate all applications using consistent criteria that apply across all priorities:

- **Organization Capability** — Does the applicant have the capacity to successfully deliver the project?
- **Collaboration** — Does the project align with community partners to avoid duplication and maximize resources?
- **Budget Clarity** — Are the proposed expenses clear, reasonable, and an appropriate use of funds?
- **Learning & Improvement** — Does the organization listen to the people it serves and adapt based on feedback?

Grant Selection Process

The Grundy County Community Foundation (GCCF) is made up of community volunteers from throughout Grundy County. This committee is responsible for making funding recommendations to the Community Foundation of Northeast Iowa's board of directors. The Committee carefully reviews and considers all eligible applications based on the guidelines stated herein. The Committee list can be found at www.grundyccf.org.

How to Apply

Applicants interested in seeking grants should fully review these grant guidelines prior to submitting an application to ensure all eligibility requirements are met. Applications must be submitted through the foundation's online grant management system. Visit <https://www.cfneia.org/nonprofits/grant-opportunities/> to access the online grant system, and to find additional resources for grant seekers.

Important Dates

- **The grant application deadline is 5:00 pm on January 15, 2026. Technical support will be available to applicants until 5:00 pm on the day of the deadline.**
- All applicants will be notified of the results of the grant process in mid-March 2026.
- Grant awards will be presented during a ceremony on Wednesday, April 22, 2026 at 5:30pm. More details will be provided with grantee notifications. **Grantees (along with staff & board members) are strongly encouraged to attend this ceremony to be recognized.**
- Grant reports, for successful proposals, are due April 30, 2027.

Instructions:

Enter each expense line item for the request in the Request Expenses column (Column A). In the Total Request Cost column, enter the total cost for the corresponding line item (Column B). The cost of the line item that is being requested from the GCCF is entered into the GCCF Request column (Column C). Any additional funding amounts for each request expense are entered separately by funding source (Column D). Enter the appropriate funding status for each funding source in the Funding Status column (Column F). You may add more rows as needed. **The Total Request Cost column must equal the GCCF Request column plus the Other Funding Source Column.**

NOTE: In-kind services or discounts should be included in the Total Request Cost column at a rate your organization would have to pay a vendor, and the amount equal to this should be shown in the Other Funding Amt column as an income.

Funding Source

Definitions:

Agency - Funds from the organization's budget or reserves

In-Kind Services - Labor or other services provided at discount or no cost or by volunteers

Grant - Grant funds for this project other than those from the GCCF, including grants pending/received from other CFNEIA Affiliates

Donations - Funds received from private individuals or businesses

United Way - Funds received through United Way organizations

Other - Funds from a source not listed

Funding Status

Definitions:

Pending - Funds have been sought, but are awaiting approval/denial

Secured - Funds have been committed but not received by the organization

Received - Funds have been received and are earmarked for the request
